Tucson Unified School District's Food Services Department announces the sponsorship of the 2012 Summer Food Services Program for Children. This program provides free breakfast and lunch meals during the summer break to children attending summer programs at qualifying school and non-school sites. The meal service is also open to any child between 2 and 18 years of age living in the neighborhood who would like to participate in the meal program even if they are not registered in a summer program at that site. Breakfast and lunch are served in school site cafeterias, and/or in designated eating areas of the non-school sites. The Program will run from May 29, 2012 to July 27, 2012. **TUSD FOOD SERVICES WILL NOT OPERATE THE SUMMER FOOD SERVICE PROGRAM – JULY 2-JULY 6.** Dates of service and meals times vary depending on the programs at each site.
